

Planning matters

East Lothian

East Lothian Council approved the outlines of the new draft proposed Local Development Plan in November but the 'public' version is still being worked on by officials. It should be available for public consultation in the summer. There is much controversy about the location of new housing in and around Musselburgh. The councillors removed one potential housing site, Goshen Farm, from the final plan. This site has lain unmanaged for some vears awaiting development and is developing into an interesting wildlife habitat. Its proximity to the Musselburgh Lagoons Local Biodiversity Site means that for the time being, there is some extension of bird usage including Grey Partridge and Curlews into and on the proposed development site. The site is now the subject of a planning appeal.

Midlothian

Both Midlothian and East Lothian Councils are operating from older, although still valid, Local Plans. Midlothian's new finalised Local Development Plan is being discussed by the Planning Committee this month (April) and the Local Development plan should be formally adopted later this year. It will be interesting to see if the Trust's comments in relation to biodiversity have been included.

The Trust has objected formally to the continued extraction of peat from Auchencorth Moss near Penicuik.

West Lothian

An exciting new river restoration project, run by the River Forth Fisheries Trust, will be adjacent to our Bog Burn SWT reserve and within the Bog Burn Lagoons Local Biodiversity Site (LBS). Julian Warman, our SWT Reserves Manager for South East Scotland, is confident that the project will be very good for habitat and biodiversity in the area as all these well run river restoration projects should be.

The council is planning the construction of a new secondary school in West Calder which will be directly adjacent to the council designated Parkhead East and Hermand Quarry LBS. From the detailed plans it looks like building work will not actually occur within the LBS boundary but that the adjacent western part of the LBS will be managed for habitat maintenance biodiversity improvement. It can always be tricky when councils develop new schools on land they own and we must watch closely that the good intentions for wildlife are actually carried out so that the kids will have West Lothian's best outdoor environmental classroom only metres from their classroom doors!

Timing is everything: Phenology and climate change. Dr. Alli Phillimore-Thursday 10th November. 7:30pm

The timing of spring events and their dependence on the weather has always captured the imagination of natural historians. Now against the backdrop of a changing climate, the observations of timings by natural historians (or citizen scientists as they are often referred to nowadays) have become an invaluable scientific resource, revealing that spring is getting earlier but that not all species are advancing equally fast.

This talk will give an overview of the research on phenology and then talk about some initial results arising from a 40-site field study looking at blue tits and how the timing of nesting impacts on the diet and growth of nestlings.

Edinburgh

A planning application for 53 residential units on a brownfield old Mill and Tannery site beside the Water of Leith LBS 70 metres Southwest of 351 Lanark Road West has been submitted. As well as being larger and taller than a previous consent on the site for a nursing home and surgery, adequate protection for legally protected Otters, Badgers and Bats around the site has not been made clear nor the effect on the Water of Leith LBS in its own right. The Council has requested further and more appropriately timed ecological survey work.

This quarter we have finished contributing to and starting the new Edinburgh Biodiversity Action Plan 2016-2018 – the City of Edinburgh Council led Biodiversity partnership of all the relevant public sector and NGO bodies that have for decades worked to improve Biodiversity within the council area together and in a coordinated manner. We helped launch the first

Edinburgh Urban Nature Conservation Strategy way back in 1992 and the EBAP's have followed continuously from this. As well as managing and promoting our 4 reserves and their special Species Action Plan species in the district: Red Moss of Balerno, Johnston terrace, Pepper Wood and of course Bawsinch including the now famous Murder Acre extension and its 'flying herd', our highlight actions including continuing with re-introducing Pillwort and of course continuing to help assess and protect Edinburgh Local Biodiversity Sites. We also contribute to the associated Edinburgh Living Landscape action plan by promoting the use of 100% native species Wildflower meadows (true meadows with grasses) especially designed for Urban Pollinators (bees, hoverflies etc.) with a longer flowering period and with no 'nectar gap months' as with traditional such seed mixes. The 'Meadow for the Meadows' near Leamington walk South was a very successful and popular example last year.
